#### ALL BREEDING ESTABLISHMENTS

##### Certificates of Identity (Foals of 2019)

1. Certificates of Identity for foals born in 2019 submitted online by 31<sup>st</sup> January 2020 will be considered for registration without any fee in accordance with Para 71(a) of the Rules and Requirements for Registration of Thoroughbred and Half-bred Horses in India – effective from 01 Dec 2019. Certificates received thereafter will attract late fees depending on the delay of receipt.

##### Stud Book Publications

2. **Statutory Publication - Return of Mares 2019.** The Return of Mares 2019 will be available by 15 Jan 2020 in Mumbai and the Stud Book Department, Pune. The cost of the same will be ₹ 250/-. Postage charges (*by Courier / Speed Post*) will be ₹ 200/- extra. Soft copies will be sent by email on request and postage charges will not be applicable.

3. **Annual Auction Sale Catalogue - 2020.** Catalogue of RWITC Ltd. Annual Auction Sale - 2020 will be available for sale in Mumbai and Pune by 20 Jan 2020. The cost of the same is ₹ 200/-. Postage charges (*by Courier / Speed Post*) will be ₹ 100/- extra. Soft copies will be sent by email on request and postage charges will not be applicable.

4. Breeding Establishments may place their orders for the abovementioned publications enclosing their remittance or ensuring sufficient credit balance in their Stud Accounts.

6. It may be noted that the Indemnity Bond for Registration of Imported Horses is required to be prepared on a bond paper of value ₹ 200/- and submitted, duly notarised. The text for the bond is available in **Appendix A** of the Rules and Requirements for Registration of Thoroughbred and Half-bred Horses in India – Effective from 01 Dec 2019.

## Microchips – Foals of 2019

8. Some breeding establishments are yet to request for microchips for **foals of 2019**.

9. The concerned Breeding Establishments are requested to kindly inform:-

(a) **Number of foals of 2019** standing at their Breeding Establishment.

(b) **Name of the Panel Veterinarian**, whose services are being used for completing the Certificates of Identity, etc.

10. The cost of the microchip is ₹ 360/- each. Sufficient balance in Stud Account be kindly maintained so as to defray the cost of the microchips.

### **Receipt of Hair Samples of 2019 Foals and Newly Registered Breeding Stock**

11. Since the foal-crop of 2012, hair samples of yearlings and breeding stock are being sent to the Stud Book Department by the Breeding Establishments. Samples are received sometimes in bits and pieces and even delayed, thereby disrupting our testing schedules.

12. Keeping in mind Annual schedules, it is imperative that all samples for the 2019 crop and newly registered breeding stock are received latest by **31 July 2020**.

13. It is also requested that one shipment of hair samples is received from a Breeding Establishment, which will include samples of foals and breeding stock.

14. The above will also facilitate the Breeding Establishment to ascertain the DNA typing charges and the due dates of payment.
