#### ALL BREEDING ESTABLISHMENTS

##### Certificates of Identity – Foals of 2020

1. Certificates of Identity of foals born in 2020 shall be issued either on-line or in paper form by the Panel Veterinarians authorized by the concerned Breeding Establishments **by 31 Oct 2020**. Such Certificates of Identity will be considered as being complete only for those horses which have been microchipped and the hair samples are received by SBAI and will be considered for registration. Certificates of Identity received after this date will incur late fees as under :-

- (a) **Certificates received by 30th Nov of the year of foaling.** ₹ 2,000/- per Certificate of Identity.
- (b) **Certificates received by 31st Dec of the year of foaling.** ₹ 25,000/- per Certificate of Identity.
- (c) **Certificates received after 31st Dec of the year of foaling.** At the discretion of the S.B.A.I. for a fee of ₹ 1,00,000/- per Certificate of Identity and subject to the reported parentage being validated.

##### Microchips – Foals of 2020

- 2. Some breeding establishments are yet to request for microchips for **foals of 2020**.
- 3. Breeding Establishments are requested to collate information of all births at their breeding establishments and request SBAI for microchips and hair sample envelopes.
- 4. Based on requests received from the breeding establishments, microchips shall be sent to them. Implantation of microchips may be carried out by the resident / contracted Veterinarian at the breeding establishments.
- 5. Hair samples of foals born in 2020 shall be collected from the foals and despatched to SBAI in the designated envelopes by the breeding establishments.
- 6. After receipt of samples by SBAI, they shall be handed over to the DNA laboratory.

## Broodmares whose Covering Returns for 2020 are yet to be received

8. Covering Returns of the following broodmares as per our records, have not been received on-line as on date. If they are received by **30 Nov 2020**, they will be considered for registration at a fee of Rs. 3,000/- each + GST @ 18%. Refer para 55 (a)(iii) of the Rules and Requirements for Registration of Thoroughbred and Half-bred Horses in India – effective from 24 Feb 2020. It may however be noted that should the Stud account be in debit at the time of receipt of the Covering Certificates, the effective date of receipt would be the date on which the account has sufficient credit to defray the late fees.
