Incomplete Sale / Transfer Deeds

1. Sale/Transfer deeds submitted to the Stud Book Authority of India for registration should be complete in all respects. As per our Rules and procedures, incomplete documents are liable **NOT** to be processed.

Broodmares whose Covering Returns for 2021 are yet to be received

2. Covering Returns of the following broodmares as per our records, have not been received on-line as on date. If they are received by **30 Sep 2021**, they will be considered for registration at a fee of ₹ 200/- each + GST @ 18% and thereafter till **30 Nov 2021** at a fee of ₹ 3,000/- each + GST @ 18%. It may however be noted that should the Stud account be in debit at the time of receipt of the Covering Returns, the effective date of receipt would be the date on which the account has sufficient credit to defray the late fees.

4. Returns in respect of Mares, which have not been covered in 2021 need to be reported on-line.

5. Names of Stallions not used for breeding in 2021 may be informed by email.

6. If any of the horses listed in Para 2 and 3 (above) have died, been destroyed or have been put out of Stud, the details may please be intimated.

List Of Stock Sheltered

7. Reference Para 86 of the Rules and Requirements for Registration of Thoroughbred and Half-bred Horses in India - effective from 24 Feb 2020.

8. A list of stock sheltered at each Breeding Establishment as on **01 Sep 2021** is due to be received by **30 Sep 2021**. All Breeding Establishments are requested to take note of the same.

9. Details of stock as per records of the Stud Book Authority of India may be viewed by Breeding Establishments using the online portal. Amendments required to the list may be informed to us via email.

Due Dates For Submission of Documents

10. Attention of all concerned is drawn to the due date for submission of the following, which is **30 Sep 2021** :-

(a) **Covering Certificates** at a fee of ₹ 200/- per certificate + GST @ 18%.

(b) **List of Stock Sheltered** as on 01 Sep 2021.

Movement of Weanlings/Yearlings/Stallions and Broodmares

11. When horses move from one breeding establishment to another, their identification documents must travel along with them. In some cases, it is observed that this procedure is not being followed. This is an essential requirement and Breeding Establishments are requested to make a note of the same. In this connection, paras **96, 97** and **98** of the Rules and Requirements for Registration of Thoroughbred and Half-bred Horses in India - effective from 24 Feb 2020 may kindly be referred to.

Passports – Foals of 2020

12. Passports of **435** foals of 2020 have been despatched to Breeding Establishments. Remaining passports are under preparation.

13. Breeding Establishments were requested to acknowledge receipt of passports. However, some acknowledgements are still awaited.

14. Breeding Establishments are required to identify the yearlings physically with the markings in the passport. In case any major discrepancies are noticed, the passports may be returned for amendments.

Provision Of Write-ups

15. For several years, Breeding Establishments have availed of our services to obtain write-ups of their bloodstock. Some of them have also had the write-ups in the form of Mini Catalogues.

16. The Stud Book Department will again endeavour to provide write-ups to all Breeding Establishments on a “first come first served” basis.

17. Write-ups will be charged at the rate of ₹ 750/- each. G.S.T. @ 18% will be extra as applicable.
